4. Pre-bid meeting shall be held at **Bhokraha Narsingh Rural Municipality, Sunsari** on **January 18, 2021 at 13:00 hours.**
5. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours on January 31, 2021.** Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend **13:00 office hours, January 31, 2021** at the office of **Bhokraha Narsingh Rural Municipality.** Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for **30 days** beyond the validity period of the bid.
7. Bidders may deposit Bid security amount in cash on Deposit Account Number : 07903000168 at Laxmi Bank, Branch : Bhokraha, Sunsari in the name of Bhokraha Narsingh Rural Municipality, Sunsari.
